**PROCEDURE:**

- Maryland Saddlery** shall determine the acceptability and has the right to refuse or return any item to the Consignor.
- Maryland Saddlery** will negotiate the price for consigned saddles on behalf of the Consignor down to the specified minimum price and contact the Consignor if the offer is for a lower price.
- If the consigned saddle has not sold after 60 days, the Consignor may be called to approve a reduction in price.
- If a consigned saddle is not sold at the end of the consignment period of four months/120 days, **Maryland Saddlery** will notify the Consignor. Unsold saddles must be picked up within ten days after termination date or reconsigned at a lower price.
- Merchandise removed before the end of the consignment period will incur a processing charge of \$5.00 per item.

**CONTRACT RESPONSIBILITY:**

- Consigned saddles will be allowed to go out on trial with perspective buyers, and be test ridden.
- Maryland Saddlery** cannot be held responsible for items left on consignment, but does agree to use all conventional safeguards in the handling and displaying of consigned goods.
- Maryland Saddlery** has the right to update and change the Consignment Contract without notice.

**PAYMENT**

- Books will close on the last day of each month. Checks will be mailed shortly thereafter.
- Payment for sold item(s) will be by check or Maryland Saddlery gift card minus applicable fees.
- For payment by check, **Maryland Saddlery** will charge a **30% commission** on saddles.
- For payment by **Maryland Saddlery** store credit a **25% commission** will be charged.
